#### **Study Question 8**

 What did this crown of thorns symbolize? Why do you think the master addressed this symbolism? (p. 124)

#### **Study Question 9**

- In this dictation Beloved Victory acknowledged the service that Saint Germain,
  Mother Mary, Jesus, the Great Divine Director, Beloved El Morya, Kuthumi and the
  entire retinue of ascended masters have rendered to mankind. Then he provided
