Study Question 5

 Daystar? What is it destined to accomplish? (p. 33)

Study Question 6

- Beloved Victory tells us that when we desire a charge of his flame, to call to him in the holy name of God and say to him:
 - "Beloved Mighty Victory, come now into the forcefield of my heart through the open door and let your flame of cosmic victory flood through my body, brain and being.
 - "Make me the completeness of God that you are. Give me your joy and your perfection, for I, too, am a son of light and a son of perfection." (pp.33-34)
